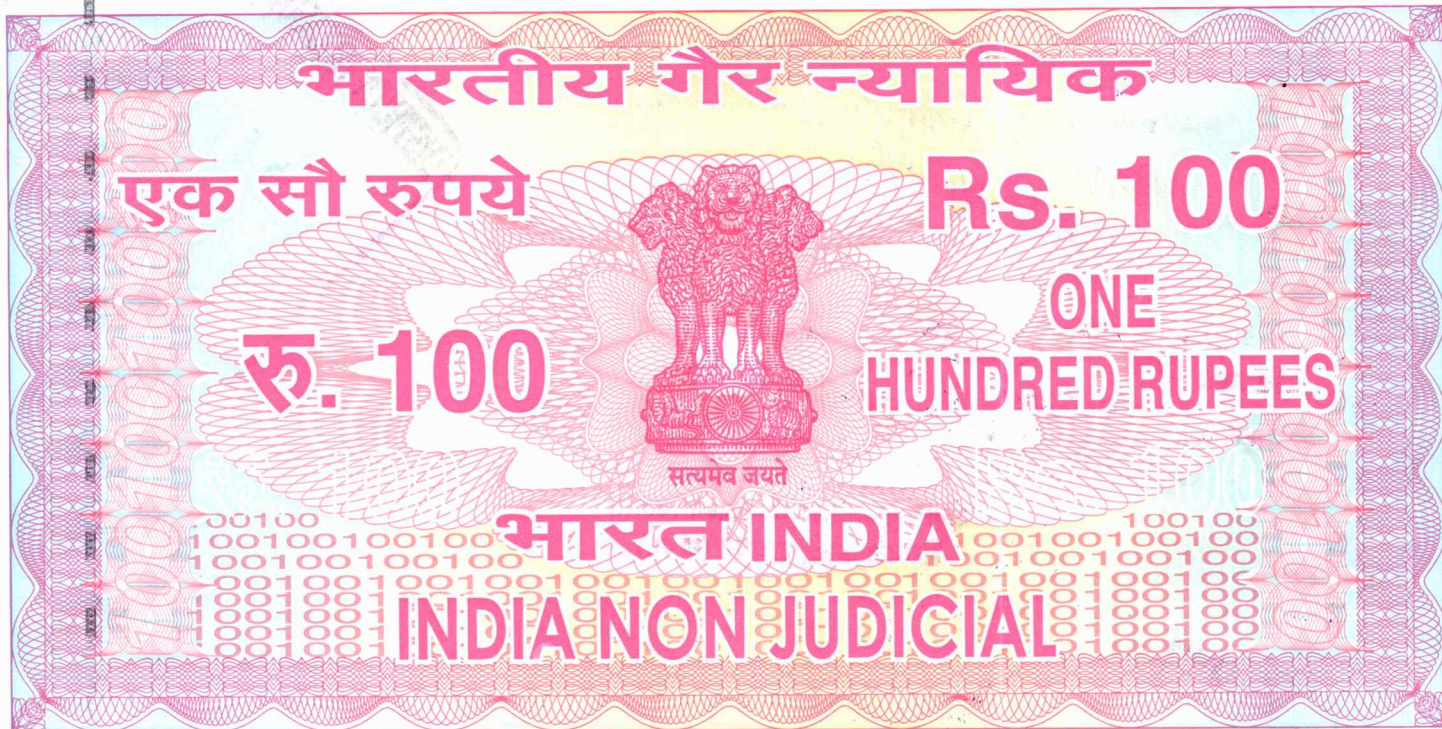

2. Roles & Responsibilities

3. Financial Terms

- ₹3,500 per candidate shall be paid directly to Student Bank account after completion of training.
- ₹500 per candidate shall be payable to University for mobilization, center and supporting purposes.
- Payment shall be reimbursed only after funds are released by the concerned Government Department.
- No advance payment shall be made before fund receipt.
- Financial terms apply specifically to PM Surya Ghar: Muft Bijli Yojana.
- For any other scheme, separate financial terms shall be mutually decided in writing.

4. Duration

This MoU shall remain valid for **1 year(s)** from the date of signing and may be extended with mutual consent.

5. Termination

Either party may terminate this MoU by giving 30 days written notice. Ongoing batches shall be completed as per agreed terms.

6. Dispute Resolution

Any dispute shall be resolved mutually. Jurisdiction shall be Raipur (City/State).

7. Eligibility

- Qualification: 10th Pass onwards.
- Age: 18 to 45 Years

8. Course Details

- Duration: 60 hours
- Total No. of Days : 08 to 10 days
- No of Batches : 1 per week, if approval granted no of batches will be increased.
- Batch size : 30
- Assessment Fees : Nil
- In case student does not appear/fails in exam then certificate and scholarship will not be provided.
